## 2018-2019 Scholarship Program

### ELIGIBILITY AND REQUIREMENTS

#### DEADLINE: March 1, 2018

#### A. Eligibility

- Applicant must be a full-time student.
- Applicant must be a U.S. citizen or documented permanent resident of the U.S. (i.e. must possess a “green card”).

##### University Construction Management Program

- 1) Must be pursuing a B.S. degree in Construction Management or construction-related program from an accredited Washington state four-year university.
- 2) Must be entering junior or senior year of university study in 2018-2019.
- 3) Must have an intention to continue a career in the construction industry.
- 4) Must have a minimum grade point average of 2.5 on a 4.0 scale.

##### Two-Year Construction Management Program

- 1) Must be pursuing a certificate or two-year A.A. degree in a construction-related program from an accredited Washington-state school.
- 2) May apply for first or second year of study.
- 3) Must have an intention to continue a career in the construction industry.
- 4) Must have a minimum grade point average of 2.5 on a 4.0 scale or demonstrate achievement of competency.

#### B. Requirements

- 1) Applicant is responsible for ensuring that all of the following items are received by March 1, 2018:
  - completed and signed application
  - one letter of reference (not to exceed one page) from faculty or faculty advisor
  - one letter of reference from faculty, current or past employer, or unrelated adult
  - **official** grade transcript from **each** college attended, or high-school transcript for high-school seniors (electronic official transcripts preferred)
- 2) Incomplete application packets will NOT be considered.

#### C. Awards

- 1) Several scholarships will be awarded ranging from \$1,125 - \$10,000 per student per year. Scholarship awards must be directed to tuition, books, and applicable fees, and may not be used for housing. Scholarship recipients may be awarded one or more of the following:

- 2) Applications will be reviewed by the Scholarship Committee of the AGC Education Foundation, which will consider applicant’s interest in the construction field, grades, extracurricular activities, employment experience, references, and potential impact on the industry.
- 3) Selected applicants will be subject to a personal interview with representatives of the AGC Education Foundation.
- 4) Scholarship recipients will be notified by June 2018.
- 5) **Grade transcripts and upcoming class schedule must be forwarded at the conclusion of each academic period.** Recipient will not be reminded to provide this information; failure to do so will result in disqualification from the scholarship program.
- 6) Checks will be sent directly to designated colleges or universities on a quarterly or semester basis after recipients have returned their transcripts and upcoming class schedules.
- 7) Recipient is encouraged to seek summer employment in construction at some time during undergraduate enrollment.
- 8) Recipient is responsible for keeping the AGC Education Foundation up-to-date on address, phone number, and e-mail changes.
